- 2 Make available NWCCU staff for employee presentations, orientations and on-site credit union visits as agreed to with your company.
- 3 Employee sign-up, service and maintenance provided entirely by NWCCU.
- 4 NWCCU will provide ongoing offers and promotions to your company Ambassador.

Your organization's responsibilities:
